

If you take a moment and look around your community, you quickly realize there is no shortage of children that need help. There is more need than ever before and the home has taken the necessary steps to address it. While my tenure as board president comes to an end in September, I know that the home has never been in better hands and I'm proud to have been part of this exciting time. While I'll continue to serve on the board, I'd like to welcome Rhonda McConnell as board president. She and her family have been champions of the home for years and will continue to support it as board president. Most importantly, thank you to the staff. What you do daily amazes me and the impact on our community immeasurable.



STATEMENT OF ACCOMPLISHMENTS

In fiscal year 2018-2019, we are pleased to report 300 referrals were received from public and private sources for Residential Services

During this time:

- 67 youth lived in the Residential Treatment Center & Raise the Age
- 36 youth lived in the Diagnostic Center
- 48 youth lived in Non-Secure Detention
- 810 instances of excitement using the Adventure Based Learning Experience

At this time:

- 79 students attended Day School
- 28 students attended the Day Treatment Program
- 63 students benefitted from the Therapeutic After School Program (TASP)

Also during this fiscal year, the community programs had success with:

- 21 boys who lived at the Boys' Group Home
 - 21 children who lived at the Ardsley Group Home
- 59 young people who were helped at the Emergency Shelter

We were able to support young people and their families:

- 25 youngsters, with their families, through the Family Support Program (FSP)
- 78 families (over 250 individuals) through the Children's Home Preventive Services (CHPS)
- Wilderness Adventure Program was utilized 935 times by residents, staff and community groups
- Close to Home Foster Care Program provided services to 180 individuals from birth to age 18
- Wendy's Wonderful Kids Adoption Program saw 2 adoptions Adoption/Homefinding Unit placed 22 children
- CFTSS served 70 people
- HCBS served 30 people
- OPWDD served 2 people
- Health Homes served 167 youth

- 83 youth employed on campus
- 30 volunteers helped with on-site programs and/or Mentor
- 108 youth participated in Equine Therapy
- 257 youth participated in: arts, clubs, fitness, games and sports
